

**A Resolution of the City of Clever, County of Christian, State of Missouri authorizing the submission of a dot-gov domain authorization letter to the Cybersecurity and Infrastructure Security Agency.**

**WHEREAS:** The City of Clever seeks to obtain and implement a top-level domain on the dot-gov root.

**WHEREAS:** The DOTGOV Act of 2020 provides for the registration and renewal of dot-gov domains at no cost to municipalities.

**WHEREAS:** Pursuant to dot-gov domain naming guidelines, CLEVERMO.GOV shall be requested in the letter of authorization.

**NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF AND FOR THE CITY OF CLEVER, COUNTY OF CHRISTIAN, STATE OF MISSOURI, AS FOLLOWS:**

1. That Scott Hackworth, Mayor is hereby authorized to execute and submit an authorization letter on behalf of the City of Clever to the Cybersecurity and Infrastructure Security Agency for registration of a dot-gov domain.
2. That Scott Hackworth, Mayor is hereby authorized and directed to furnish such information as the Cybersecurity and Infrastructure Security Agency may reasonably require in connection with the authorization letter and process which is herein authorized, to sign all necessary documents on behalf of the applicant, to furnish such assurances to the Cybersecurity and Infrastructure Security Agency as may be required by regulation.

**A Resolution of the City of Clever, County of Christian, State of Missouri declaring the month of September 2022, to be National Suicide Prevention Month in Clever, Missouri.**

**WHEREAS:** National Suicide Prevention Month is a time to bring awareness to mental health and awareness to death by suicide in the community and to reaffirm our commitment to promoting resources, raising awareness, and fostering conversation; and

**WHEREAS:** death by suicide is the 12th leading cause of death in the United States for all ages according to the CDC in 2020; and

**WHEREAS:** September marks the time to recognize the hard work that mental health advocates, prevention organizations, survivors, allies and mental health professionals do to save lives; and

**WHEREAS:** death by suicide touches the lives of many people in our community. Therefore, we all have an obligation to learn about prevention and share resources of the signals and signs of suicidal thoughts so that we may identify and offer support before it is too late; and

**WHEREAS:** in September we grieve alongside the families of those that we have lost to death by suicide and renew our commitment to do better as a community for all mental health concerns.

**NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMAN OF AND FOR THE CITY OF CLEVER, COUNTY OF CHRISTIAN, STATE OF MISSOURI, AS FOLLOWS:**

1. That the Mayor and Board hereby declare the month of September 2022, to be “National Suicide Prevention Month” in Clever, Missouri.
2. That in the City of Clever, Missouri’s commitment to the promotion of suicide prevention, educational literature shall be made available in City Hall, the Police Department; and that a badge promoting the new 988 Suicide & Crises Lifeline shall be placed on the city’s website which shall link to the service.
3. BE IT FURTHER RESOLVED the Mayor and Board encourage all citizens of Clever to take part in National Suicide Prevention Month by promoting the education and prevention of suicide.
